MSBOC and MS AG join forces to fight fraud

Response to crooked contractors that bad business won't be tolerated in the Magnolia State and violators will be prosecuted.

Mississippi has been hit hard by storms in 2013, everything from tornadoes to hail storms, causing an increase in unlicensed and fraudulent contractors moving to the state looking for work. "While there are a lot of honest contractors out there, a disaster really brings out the crooks trying to take advantage of those already in a vulnerable position," said Attorney General Hood. "That's why we are joining forces with the Board of Contractors to send the message that we are united in our fight against crooked contractors."

MSBOC disaster response teams have been out in storm stricken areas warning property owners about unscrupulous contractors and following up on complaints. "By joining forces with the Attorney General's Office, we hope to keep storm-damaged residents from being victimized by an unscrupulous contractor," said Stephanie Sills Lee, Executive Director of MSBOC.

A conviction for Home Repair Fraud could result in up to ten years behind bars. The MSAGO and the MSBOC both intend to prosecute, to the fullest extent of the law, anyone caught committing home repair fraud.

Competition Showcases Construction Skills

he Mississippi Construction Education Foundation (MCEF) in conjunction with the Mississippi Department of Education and several industry partners recently hosted the 2013 SkillsUSA Mississippi State construction championship at the Trademart in Jackson.

The competition offered high school and community college students along with other skilled crafts persons enrolled in MCEF's apprenticeship program a chance to their showcase skills in 11 construction craft areas including carpentry, masonry, sheet metal and HVAC. The winners advanced to the national competition.

This is the first year MCEF partnered with SkillsUSA to host the MSBOC competition. helped support the event by donating a portion of penalties collected by the board for the educational opportunity. Promoting а partnership of students, teachers and industry working together helps ensure a skilled workforce for the future.

MSBOC board members Tommy Kline, Tony Carroll and George Marler helped judge the competition that included competitors from Mississippi high schools, colleges and apprenticeship programs.


